BUSINESS

Resolution Italthai: Assignment of mortgage by City of Ithaca to Ithaca Urban Renewal Agency

Ms. Geldenhuys explained that the project is refinancing and the City of Ithaca is transferring the assignment of the mortgage to the IURA. The IDA is being asked to consent due to its leash hold interest in the project. This does not change the PILOT agreement.

TCAD 2013 Accomplishment and 2014 Work Plan – Update

Ms. Armstrong gave an overview of the 2013 Accomplishments and the 2014 Work Plan.

2013 was a great year and a lot of energy was expended on a number of projects.

The TCAD Foundation came into being. This foundation will help with TCAD's efforts around workforce development. The first board is the current TCAD Executive Committee. The Foundation's first independent board is soon to be formed.

TCAD's efforts around the airport and the Cayuga Operating Power Plant were discussed. David Marsh emphasized that the power plant is very important to the area.

Ms. Armstrong also discussed the Technology Task Force that was formed and developed a number of outcomes that will impact TCAD's efforts in 2014.

2014 will also see an update to the Economic Development Strategy.

TCAD's 50th Anniversary will also be celebrated in 2014.

Ms. Robertson suggested also working closely with the Ithaca College Business School in addition to CCTEC and Cornell University.
